7	Student progress to degree – information on individual students arranged by advisor; for review of timelines and milestone requirements	Identify locations where program milestones should be listed and communicated to students and faculty advisors.	Graduate Studies will send the Student progress to degree information to graduate coordinators. Programs are asked to reach out to students who are not registered this semester but are slated to graduate in December or May of this academic year, and to get them enrolled. Programs were also asked to work with students who have not advanced to candidacy but who have earned a large number of units and students are nearing the 7-year limit, to develop plans for completion, as well as students nearing the limits for financial aid.
