Deadlines & Announcements

March 10- Submissions for <u>the Patricia O. McConkey Outstanding Graduate Student</u> are due. These awards recognize the outstanding student graduating with a master's degree from each program. There will be multiple McConkey awards; each program may select one awardee. Students who will have completed a master's degree between May 2023 and May 2024 are eligible.

March 11 - Last day to change registered class grade option to CREDIT/NO CREDIT. Only one optional CR/NC course can be taken per term.

March 11-15 - SPRING BREAK

March 22 - The class schedule for Fall & Summer 2024 will be available online by noon.

March 28 - Deadline: WITHDRAW (prorated refund*) – Last day to request permission to withdraw from the spring semester and be eligible for a prorated refund of less than \$20 per course and a \$27 administrative charge*. Permission to withdraw and documentation of a serious & compelling reason is required. A grade of "W" will be recorded for each course. After this date, students are not eligible for a refund of fees.

April 1 - Deadline: WITHDRAW (serious & compelling) – Last day to request permission to withdraw from one, some, or all courses. **Permission to withdraw and documentation of a serious & compelling reason is required.** A grade of "W" will be recorded for each course. (Not eligible for fee refund. There is a \$20 per course charge, (plus an additional \$27 administrative charge for withdrawal from all courses.) After this date, withdrawal is not allowed, except for catastrophic reasons.

April 2 - Students must file a FAFSA (Free Application for Federal Student Aid) no later than **April 2nd** for the 2024/2025. Please note, the priority deadline of **March 2nd** will be in effect for all future filling cycles.

April 15 - Deadline for Programs to forward the names of graduate **TAs and GAs** for the next academic year to the Graduate Studies Office through this form.

The deadline to submit **GFWS** Proposals for the 2024-2025 Academic year through this form.

Deadline to submit prospective students to receive a **Non-Resident Fee Waiver** through this form.

April 22 - Deadline: Last day to request a master's thesis or project format review.

May 6 - Deadline: Last day to submit final master's thesis or project for Spring 2024 graduation.

May 11 - Spring 2024 Commencement Ceremonies.

May 15 - Deadline – Last day to change a Spring 2024 graduation date without a fee. Deadline for students to accept the Non-Resident Fee Waiver award and notify the Graduate Studies Office.
