3. **GA/TA Fee Waivers, Non-Resident Fee Waivers and Changes to SUG** (Peggy Metzger, Katie Kitchen, Amanda Parker)

Context: Waiver process became complicated this summer 2025. Staff turnover, changes to SUG, and student and coordinator emails/stress.

Goal: Devote some time to discuss waiver types and discuss our processes around them. Discuss policies and any changes from 2010 version.

Overview of Waiver types: Peggy Metzger

EO 611 - (GA/TA Fee Waiver) EO 1082 - Non-resident waiver

- It's not money it's a waiver. No tuition is coming into the university.
- Not a salary. The TA salary is part of the Dept budget.
- In the past, campus looked at #s of waivers (ex. 15 students). The number changes every year.
- In the past, a student got SUG OR waiver (not both). With changes to SUG, it put more pressure on waivers.
- Kacie Flynn in Sponsored Programs confirmed that GA/TA waivers are not available for grant funded students
- This year, there were last minute changes to SUG and many students lost eligibility.
- Number of waivers was 27 total for this year Financial Aid (FA) used names/information that grad coordinators had put forward at time of deadline in 2025.

Eligibility:

NOT eligible for GA/TA Fee Waiver:

- Submitted FAFSA after March 2nd
- No FAFSA on file
- No remaining unmet need
- EFC (Expected Family Contribution) greater than \$20,000
- SUG recipient
- Reached Unit Cap for degree

YES - ELIGIBLE for GA/TA Fee Waiver:

- Submitted FAFSA by March 2nd
- Has unmet need
- EFC below \$20,000
- Under major Unit Cap, and meets other academic standards

Process:

 Grad coordinators/Depts submit names to Grad Studies for waivers and # of units waiver covers for the academic year.

- Grad Studies checks schedules and ensures units are relevant to the graduate program. FA has to wait for that confirmation before they can award.
- Grad Studies submitted their list to Financial aid. FA checks eligibility and sends a list back of who is eligible for waivers.
- FA then posts waivers to the accounts as a placeholder (coordinates GA/TA and Non-resident awarding)
- If the past, final decisions (ex. Limited Waiver units needed by multiple students) was made by Graduate Dean.

Ex. out of state grad student enrolled in 9 units – they pay campus tuition, campus fees, and 9 times out of state (which is 9×400). The program may ask to waive 3 of those units.

Recommendation/Feedback/Suggestions

- Larger Budget Conversation: Departments cover TA salaries as part of their budget. In the future, consider base budget funding for graduate students based on campus needs
 determine what this costs campus and cost/benefit analysis
- Process and Determining Who Gets the Waiver:
 - Criteria for determining which student gets fee waivers was opaque in the past– Recommend more transparent and objective process and procedures going forward
 - Factors of who gets the waiver in the past, final decision was made by Graduate Dean. Heather recommends shared governance to make those decisions and a more equitable process in the future.
 - Timeline issues Depts make decisions and when are those decisions communicated to grad studies and the students? Inequity in the process can come from aligning different Department processes and timelines.
 - Graduate Admissions and Support for Grad Students how much is allocated to the programs, and when can that be communicated to students?

Internal Deadlines, Application Deadlines, and Financial Aid deadlines

- FA starts packaging aid in early March
- April 1 campus deadline for Depts to submit waiver requests
- Can be very tight for departments whose applications close March 15 for instance
- Grad Studies/FA review lists by mid-April
- Awards start to go out, there are waitlists for aid too.
- The last couple years, the FAFSA deadlines have also fluctuated and been pushed back into April and May, which complicated the process.
- When do students find out about SUG eligibility typically? March or April typically.
 - In 2025, big changes to SUG and students with certain SAI scores could not be packaged until later for continuing students AND new students
